

Vietnam Swordfish Handline Fishery Improvement Project
ADDENDUM N1 to the FRAMEWORK AGREEMENT

This Addendum to the Framework Agreement of the Vietnam Swordfish Handline Fishery Improvement Project executed on July 4th 2018 is entered into by and between the Parties shown here.

Sea Delight LLC, hereinafter referred to as Sea Delight, with domicile in 8195 N.W. 67th Street Miami, FL 33166, USA, represented by Stephen Fisher; the Centro Desarrollo y Pesca Sustentable, hereinafter referred to as CeDePesca, with domicile in Edificio Jardines de Vista Hermosa, PB-F, Panama City, Panama, represented by Ernesto Godelman.

First: FIP partners will be classified in two types: Overseas FIP partners (importers, processors, distributors in foreign countries, independent of whether they have facilities in Vietnam or not) and Local FIP partners (Vietnam-based companies).

Second: Any new interested party admitted as Overseas FIP partner will be required to equal the contribution made by original Overseas FIP partners in years prior to its admission, as well as contributions already made to the budget in place at the time of entry. Subsequent installments of the budget in place at the time of entry will be recalculated taking into consideration the new number of Overseas FIP partners. Any remainder will be applied to the budget of the subsequent year. In case there is no subsequent year needed to complete the goals of the FIP, then any remainder will be used to hire a Conformity Assessment Body (CAB) to conduct an MSC pre-assessment or an MSC full-assessment of the fishery.

Third: Any new interested party admitted as Local FIP partner will be required to make a fixed single annual contribution to the FIP in the amount of USD \$5,000.00 (five thousand US dollars). This contribution will be applied to the budget of the subsequent year. In case there is no subsequent year needed to complete the goals of the FIP, the funds will be used to hire a CAB to conduct an MSC pre-assessment or an MSC full-assessment of the fishery.

Fourth: A traceability system and a proprietary QR Code will be designed and implemented as part of this FIP, and Sea Delight (and any other Overseas FIP partner subsequently joining) will contribute to its financing. The traceability system will assure the origin of the marked products along the whole supply chain to the last link before final consumers. In joining the FIP, all FIP partners, Overseas and Local, commit themselves to using the official traceability system to be designed for all FIP products. The trace code system will be used on all swordfish products packed in and exported from Vietnam, whether the raw material swordfish is from Vietnamese FIP vessels or other sources.

Fifth: The proprietary QR code, linked to an informational web page about the FIP, will be available to all FIP partners for Business to Business communication, but only on the packaging of Overseas FIP Partners that is clearly identified as their branded product and made with handline swordfish caught by Vietnamese vessels.

Sixth: Non-compliance with clauses related to traceability and financial contributions as set in the Framework Agreement, its Addendums and standing Specific Agreements will result in the automatic removal of the non-compliant FIP partner if the issue is not solved within 30 days of receiving written electronic notice by the FIP coordinator.

This Addendum is signed in originals of equivalent legal value.
