ARGENTINA FLATHEAD – BOTTOM TRAWL FIP ADDENDUM № 1 to the FRAMEWORK AGREEMENT AND SPECIFIC AGREEMENT №1

This Addendum to the Framework Agreement is entered into by Comercial INAL 2005, S.A., hereinafter referred to as INAL, with domicile in Parque Industrial General Savio, Mar del Plata, Argentina, represented by Santiago Aufranc; Mardi Alimentos S.A., hereinafter referred to as Mardi, with domicile in Batalla de Pari 860, Buenos Aires CP 1416, Argentina, represented by David Gabriel Lavanchy; Frigosur S.R.L., hereinfacter referred to as Frigosur, with domicile in Brumana 392, Mar del Plata B7608EUH, Argentina, represented by Juan Carlos Aicega; and Centro Desarrollo y Pesca Sustentable, hereinafter referred to as CeDePesca, with domicile in Edificio Jardines de Vista Hermosa, PB-F, Panama City, Panama, represented by Ernesto Godelman. The Addendum is written within the context provided by the Framework Agreement signed on 28 October 2023 by Simplot Australia Pty. Ltd., Pacific West Foods Australia Pty. Ltd. And CeDePesca.

First: INAL, Mardi and Frigosur accepts all conditions set for the successful execution of the Argentina flathead – bottom trawl FIP, as described in the Framework Agreement and Specific Agreements signed to date.

Second: Pursuant to Clause Sixth of the Framework Agreement related to the admission of new FIP partners, CeDePesca, on behalf of the current FIP partners, welcome INAL, Mardi and Frigosur to the Argentina flathead – bottom trawl FIP as FIP partners.

Third: INAL, Mardi and Frigosur acknowledges that a Prospective FIP (FIP Stages 0-2) was completed by Simplot and CeDePesca to identify the improvement needs of the fisheries and to design the FIP Action Plan that was subsequently adopted by Simplot, Pacific West and CeDePesca through Specific Agreement N1 signed on 28 October 2023.

Fourth: In order to contribute to the implementation of the activities set in the FIP Action Plan for Year 1, INAL, Mardi and Frigosur agree to make a financial contribution corresponding an amount of per tonne ordered, shipped and fully paid by the Australian customers or the companies designated by them, to the Argentine producers.

Fifth: INAL, Mardi and Frigosur will make the contributions to Cedepesca, after receiving an invoice in US dollars for the amounts communicated by the partners. Cedepesca will prepare a complete semi-annual report on the movements and use of the funds provided.
